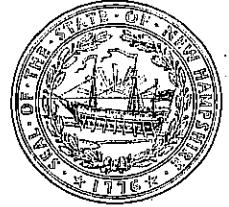

Dear Mr. Chapman and Mr. and Mrs. Coleman:

As you know, a pre-hearing conference relative to the above-captioned appeal was previously scheduled for Monday, September 24, 2007 at 9:00 a.m. On September 11, 2007, the Petitioner in this matter (Renate Ranniger) filed a Motion for Continuance pursuant to Env-WtC 205.19 to continue the pre-hearing conference scheduled for September 24, 2007. The Motion represented that the Petitioner's original counsel was no longer available, and that while Petitioner has retained new counsel, the new counsel needed time to prepare for the pre-hearing conference and in any event was not available on the morning of September 24, 2007.


The Motion also represented that Petitioner's former counsel had obtained the consent of the applicants (James Coleman and Anna Coleman) to a continuance of the pre-hearing conference of 30 days or more.

On September 21, 2007, Presiding Officer John Cobb granted the motion. The pre-hearing conference in this matter has been rescheduled for Monday, November 19, 2007 at 9:00 a.m. in Room 110 of the offices of the Department of Environmental Services, 29 Hazen Drive, Concord, NH.

At the pre-hearing conference, the parties should be prepared to discuss simplification of the issues in the appeal, stipulations or admissions as to facts, the number and identity of witnesses the parties anticipate calling at the hearing, exhibits necessary for the appeal, and any other matter that may aid in the disposition of the appeal, including settlement.
