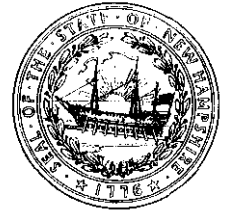

The Notice of Appeal of the Department of Environmental Services Decision on Reconsideration denial of July 18, 2007 relative to Wetlands File No. 2007-00321, which you filed on behalf of Tom McKay / Hi Spot Condominium, was received by my office on August 13, 2007. This appeal has been assigned Docket No. 07-18 WtC. Please refer to this docket number in all future correspondence relative to this appeal. I have forwarded the notice of appeal NH Wetlands Council ("the Council"). In accordance with Env-WtC 204.03 I expect the Council will vote to accept or dismiss the appeal at its October 2, 2007 business meeting. This meeting is simply a regular Council business meeting, not a hearing; therefore your attendance is not required. If the Council accepts the appeal a pre-hearing conference will be scheduled.

In accordance with NH Code of Administrative Rules Env-WtC 100 and 200 any party wishing to participate in this appeal must file a motion to intervene and/or an Appearance with the Council.

Please note that any document filed in conjunction with this appeal shall be filed by mailing or delivering the original and 15 copies of the document to the Council Appeals Clerk. Additionally, a copy of the document must be sent to all parties to the appeal and to any person who has a motion to intervene pending before the Council. Every document filed with the Council, and required to be served upon the parties to the appeal, shall be accompanied by a certificate of service, signed by the person making service, attesting to the method and date of service, and the persons served.
